Welcome and call to order.

Dr. Elsie Olan, chair, called the meeting to order at 2:35p.m. and welcomed the committee and guests. A quorum was established. The minutes (program, course) from the March 6, 2019 meeting were reviewed and approved.

General Business.

Emily Stettner announced that the minutes from this meeting will be emailed to the Committee for their approval and edits. She reminded the Committee that this is the last meeting of the academic year so no more proposals will be reviewed until the Committee resumes in the Fall. The College of Graduate Studies will still be accepting requests for special topics courses over the summer.

Dr. Devon Jensen informed the Committee that Curriculog will be shut down on April 1st to allow for system updates in preparation for next year. Proposals that are currently in Curriculog at pending levels prior to the Committee step will be wiped from the system and a new proposal will need to be created on the new 2019-2020 proposal forms.

Inactivation of CGS Professional Science Master's Track of Modeling and Simulation MS.

Dr. Paul Wiegand explained the degree is now obsolete due to changes to the Modeling and Simulation MS program. There are no students enrolled in this program and it has not been active for more than two years. The program inactivation received unanimous approval.

Revision of CBA Business Administration MBA, Evening Track.

Dr. Jeff Reinking explained the revision is to remove course BUL 6444 from the curriculum for this program and replace it with course BUL 5332. BUL 6444 will still be taught for use in other business programs. The program revision received unanimous approval.

Revision of CBA Economics MS.

Dr. Michael Caputo explained the revision is to remove course MAP 6207 which is currently taught by the math department and replace it with course ESI 5306. Also, ECO 6445 will replace HIM 6217C. HIM 6217C is a market rate tuition course and this is presenting difficulty in calculating student fees for the Economics MS program which is not market rate. The program revision received unanimous approval.

Revision of CBA Management MSM, Business Analytics Track.

Drs. Sevil Sonmez and Morgan Wang explained the revisions are to lists of course choices within the program. On the required course list MAN 6721 will be added. The revisions to the business analytics specialization course list include: removing STA 6714, STA 5703, STA 6704 and adding GEB 6210, STA 5711, STA 5712. The program revision received unanimous approval.

Revision of CCIE Educational Leadership EdD, Higher Education Track.

Dr. Kathy King explained the revisions are to replace core course EDH 6046 with EDH 7047 and to update course EDF 7XXX in the research course list with its approved course number EDF 7483. The program revision received unanimous approval.

Revision of COS Integrative Anthropological Sciences PhD.

Dr. John Walker explained the revisions are to remove the take-home portion of the qualifying exam and to require an on-campus exam. The revision will remove course ANG 6002 from the qualifying exam materials. The program revision received unanimous approval.

Revision of COS Physics MS & PhD - Planetary Sciences Track.

Dr. Joseph Harrington explained the revision is the same in both the MS and the PhD programs. The revision will remove core course PHZ 5156 as a choice and only have course AST 5765. The program revision received unanimous approval.

Revision of CGS Geographic Information Systems Graduate Certificate.

Dr. John Walker explained the revision is to add course HIS 6167 to the group C electives list. The certificate revision received unanimous approval.

Fees.

Dr. Kim Anderson explained the new Materials and Supplies fee request is to cover the purchase of Dedoose software for students enrolled in course PAF 7868. The software is unique in that it is mixed method using both qualitative and quantitative data. The fee is per student for a four month subscription. The amount of students in the course does not impact the fee. The fee addition received unanimous approval.
