# Revisions to the online Instructional Technology/Media-Educational Media Track (Ed Media) Master of Education (M.Ed.)

## **Rationale for Ed Media Program Revisions and Updates**

The online Master of Education (M.Ed.) Educational Media (Ed Media) track is a graduate-level initial teacher preparation program for PK-12 Florida public school teachers training to become PK-12 Florida public school library media specialists. For the past few decades, public school media specialists were granted Ed Media certification by completing an Ed Media Bachelor's or Master's degree and passing the Educational Media Specialist (PK-12) Subject Area Examination (SAE) portion of the Florida Teacher Certification Examination (FTCE).

Effective July 1, 2002, certification in PK-12 Educational Media is granted by passing the Educational Media Specialist (PK-12) Subject Area Examination (SAE) portion of the Florida Teacher Certification Examination (FTCE). Full Professional Educator's Certification, however, also requires demonstration of pre-professional level competencies in all twelve Florida Educator Accomplished Practices and additional competencies listed in State Statute and State Board of Education Rule. This requires additional formal education through postsecondary institutions or school districts.

In order to address the certification by test rule, a 12 credit hour Online Ed Media Graduate Certificate was implemented in summer 2004. The 12 credit hours will transfer into the Ed Media M.Ed. Since inception of the Ed Media Certificate, 123 applications for acceptance into the certificate program have been submitted.

Given the strong interest in the Online Ed Media Certificate program and an aggressive plan to recruit Certificate students into the Online Ed Media Masters, the online Masters curriculum and the program requirements were assessed and a decision made to update and revise the current Ed Media Program of Study. (see Addendum A) Additional program changes demonstrating compliance with State Board of Education Rule 6A-5.066 were also considered.

The result is a revised 36 credit hour Ed Media Program of Study (see Table 1) and updated program requirements. It is believed these changes will attract new Masters students and be an incentive for Ed Media Certificate students to move into the Masters, as well as improve the relevance of the curriculum for Florida public school media specialists.

## Ed Media Program Revisions and Updates

- Eliminating Option A-Research Report and Option B-Non-Thesis from Area A of the Program of Study. (see Addendum A)
- Revising Area A: Educational Core Course Requirements (see Addendum A):
  - a. Drop EDF 6481 Fundamental of Graduate Research and EDF 6432 Measurement and Evaluation in Education
  - Move EME 6062 Research in Instructional Technology into Educational Core courses
  - c. Add RED 5147 Developmental Reading

NOTE: Changes b. and c. are based on existing courses.

- Requiring students to pass the Ed Media Subject Area Test as a graduation requirement.
- 4. Updating Admission requirements in the Ed Media Masters to read:

**Testing/Academic Requirements:** An earned bachelor's degree from an accredited university or college AND a GRE score of at least 1000 (combined verbal and quantitative score) AND a GPA (Grade Point Average) of at least 3.0 in the last 60 hours of the undergraduate (earned bachelor's degree) program

## OR

An earned bachelor's degree from an accredited university or college AND a GRE score of at least 840 (combined verbal and quantitative score) AND passing scores on all sections of the CLAST (if prior to July 1, 2002) or the FTCE General Knowledge test AND a GPA (Grade Point Average) of 3.0 or higher for the last 60 hours of the undergraduate (earned bachelor's degree) program.

NOTE: All test scores must be on file at UCF/Graduate Studies to be considered for admission.

**Florida Professional Educator's Certification:** Students must have completed all requirements and been granted the Florida Professional Educator's Certificate to be considered for the online Ed Media M.Ed. This includes completion of all required coursework, completion of a full-time 10-week internship and having passed all applicable sections of the FTCE tests (i.e., General Knowledge Test, Subject Area Examination in the prior certification area and Professional Education Test).

NOTE: A copy of the student's Florida Professional Educator's Certificate must be on file at UCF to be considered for admission into the M.Ed. in Ed Media.

## State-mandated ESOL Requirement:

- Providing evidence of having completed district-level 60-hour ESOL training OR
- b. Providing evidence of having completed an undergraduate or graduate level course that meets the state requirement for ESOL (i.e., a course that satisfies the district-level 60-hour ESOL training requirement) OR
- c. Completing TSL 5373 Teaching Language Minority Students in K-12 Classrooms (see Addendum B: Email regarding an TSL 5373 online course) as a program co-requisite.
- Adding RED 5147 Developmental Reading to meet state mandated Reading Endorsement Competencies 2 (see Addendum C: Letter of Support
- Requiring 3 credit hour internships for all students in the Ed Media program :

a. Students currently working as a public school media specialist while in the Ed Media Masters must complete a 45- hour, 3 Credit Hour jobsite internship OR

b. Students in the Ed Media Masters not working as a media specialist must complete a 45-hour, 3 Credit hour regular internship at an approved public school media center.

## Table 1 Catalog Information

## Master of Education in Instructional Technology/Media (36 hours)

The online Master of Education (M.Ed.) in Educational Media is a totally Webbased program that prepares FL PK-12 public school teachers to become FL PK-12 school library media specialists. The program is designed for the student who has completed all requirements and been granted the Florida Professional Educator's Certificate. This includes completion of all required coursework, completion of a full-time 10-week internship and having passed all applicable sections of the FTCE tests (i.e., General Knowledge Test, Subject Area Examination in the prior certification area and Professional Education Test).

A copy of the student's Florida Professional Educator's Certificate must be on file at UCF to be considered for admission into the M.Ed. in Ed Media.

At least one year of successful classroom experience is preferred. Completion of the Masters leads to certification in Educational Media as a FL PK-12 school library media specialist. Ed Media students are required to pass the Educational Media Subject Area Test in order to graduate from the online Ed Media program.

The online Educational Media program of study is designed to offer skills in administration, production, instructional design, organization, selection, evaluation and research that relate to FL PK-12 school library media programs. Knowledge and applications of both present and future innovations and technologies for education are stressed.

The online Educational Media Masters is accredited by the National Council for Accreditation of Teacher Education (NCATE) and approved by the Florida Department of Education (DOE). Standards developed by the 1) American Association of School Librarians (AASL) and the American Library Association (ALA), 2) NCATE and the 3) FL DOE to include the Florida Educator Accomplished Practices and the Ed Media Subject Area Competencies guide the development of the Ed Media program and are integrated into Ed Media courses.

## CURRENT CURRICULUM

# Master of Arts in Anthropology

Degree-seeking students in both the Archaeological Investigations in Forensics and Human Adaptation and the Cultural Competence in the Profession tracks of the Anthropology program may elect to follow either a thesis or a nonthesis course of study. The thesis option is designed for students who plan to enter doctoral programs, while the nonthesis option is more appropriate for students entering or continuing professional careers following the M.A. degree. The Master of Arts degree is conferred when students have fulfilled the requirements of either the thesis or nonthesis option. Both options require 30 hours of course work, at least 15 of which must be at the 6000 level or above. No graduate credit will be given for any grade lower than a B- (2.75), but the grade will be counted toward the GPA. Courses may be retaken to achieve a better grade; however, students must maintain a minimum GPA of 3.0 in their program of study.

Upon acceptance into the program students will be assigned a faculty adviser. Together the students and their advisers will determine the student's preliminary program of study, either in the thesis or nonthesis track. Students should maintain close contact with their faculty adviser in order to develop a viable program of study and avoid graduation delays. For thesis students, the faculty adviser will chair their Thesis Advisory Committee, which also will include two additional faculty members: two from Anthropology, one of whom is the Chair, and one from another Program or Department. Qualified individuals from outside the University of Central Florida may be eligible to serve as the third member of Thesis Advisory Committees. The additional members of the Thesis students, a committee of two additional faculty members will be selected in consultation with the student's faculty adviser. For nonthesis students, a committee of two additional faculty members will be selected in consultation with the student's faculty adviser for the purposes of the oral examination. This committee must be selected by the semester prior to the semester in which the student will take the oral exam.

Research studies are required in the required courses, and at the conclusion of all course work, an assessment of students independent research projects and papers is completed. The research study will focus on reviewing and analyzing contemporary research in a students particular specialization within anthropology in order to help students acquire knowledge and skills pertaining to research-based best practices in that specialization area.

## Minimum Hours Required for M.A.—30 Credit Hours

Degree-seeking students in the anthropology program may elect to follow either a thesis or a nonthesis course of study. Both options require 30 hours of course work.

## Required Core Courses—9 Credit Hours

Students in both tracks will be required to complete three core courses. Together, these courses provide an in-depth understanding of the epistemological foundations of the discipline. Students are introduced to the theory and practice of Anthropology at a level of synthesis that will prepare them for future doctoral study should they wish to pursue it. These courses will also establish the foundations of understanding that will prepare students for nonacademic careers that employ anthropological perspectives and knowledge.

- ANG 6110 Archaeological Theory and Method (3 credit hours)
- ANG 6587 Seminar in Biological Anthropology (3 credit hours)
- ANG 6930 Seminar in Cultural Anthropology (3 credit hours)

## Required Track Courses—6 Credit Hours

The required courses designed for each track provide the fundamental disciplinary content and expertise necessary for competence in that specialization. Students will receive training in the theory, methods, and application of their respective areas of study.

## Elective Courses—9 Credit Hours (Thesis Option) or 15 Credit Hours (Nonthesis Option)

Students who are completing the thesis option will select a minimum of 9 credit hours of nonrestricted electives in consultation with their faculty adviser. Students completing the nonthesis option will select a minimum of 15 credit hours of nonrestricted electives in consultation with their faculty adviser. No more than 3 credit hours may be taken in UCF graduate programs outside the department. The department's graduate director must approve all courses taken outside the department prior to enrollment.

Under special circumstances, students may enroll in a graduate-level Directed Independent Study course or a Directed Independent Research course to fulfill their nonrestricted elective course requirements. These courses, like most graduate seminars, require written research reports. Enrollment in these courses requires written approval from the student's adviser. No more than 6 hours of graduate-level courses in Directed Independent Study or Directed Independent Research may be included in a student's program of study.

## Thesis and Nonthesis Options

Thesis Option (6 Credit Hours of Thesis)—The thesis and oral defense are the culmination of the course work for those students who have elected the thesis option. Students electing to write a thesis must select a Thesis Advisory Committee. The student's faculty adviser will chair the Thesis Advisory Committee. The committee will consist of three members: two from Anthropology, one of whom is the Chair, and one from another Program or Department. Qualified individuals from outside the University of Central Florida may be eligible to serve as the third member of Thesis Advisory Committees. The completion of the thesis must be followed by an oral defense before the Thesis Advisory Committee. A successful format review, oral defense, and electronic submission of the thesis to the Division of Graduate Studies for review completes the program requirements. Students are expected to follow all procedures and timetables specified by the Division of Graduate Studies.

Nonthesis Option (6 Credit Hours of Electives)—The student selecting the nonthesis option will take an additional 6 hours of elective course work, for a total of 15 credit hours of electives. At the conclusion of this course work, the student will be given a comprehensive oral examination. In consultation with the faculty adviser, two additional faculty members shall be selected to serve on the Oral Examination Committee that will be chaired by the faculty adviser. A successful comprehensive oral examination completes the requirements for the degree. Students are expected to follow all procedures and timetables specified by the Division of Graduate Studies.

## Archaeological Investigations in Forensics and Human Adaptation Track

## Master of Arts in Anthropology

Degree-seeking students in the Archaeological Investigations in Forensics and Human Adaptation, the Cultural Competence in the Professions, and the Maya Studies tracks of the Anthropology program may elect to follow either a thesis or a non-thesis program of study. The thesis option is designed for students who plan to enter doctoral programs, while the non-thesis option is more appropriate for students entering or continuing professional careers following the M.A. degree. The Master of Arts degree is conferred when students have fulfilled the requirements of either the thesis or non-thesis option. All options require 33 hours of course work, at least 50% of which must be at the 6000 level or above. No graduate credit will be given for any grade lower than a B- (2.75), but the grade will be counted toward the Graduate Status GPA. Courses may be retaken to achieve a better grade; however, the unsatisfactory grade will remain in the program of study. In order to stay in good academic standing, students must maintain a minimum Graduate Status GPA of 3.0 in their program of study.

Upon acceptance into the program students will be assigned a faculty adviser. Together the students and their advisers will determine the student's preliminary program of study, either in the thesis or non-thesis track. Students should maintain close contact with their faculty adviser in order to develop a viable program of study and avoid graduation delays. For thesis students, the faculty adviser will chair their Thesis Advisory Committee, which also will include two additional faculty members: two from Anthropology, one of whom is the Chair, and one from another Program or Department. Qualified individuals from outside the University of Central Florida may be eligible to serve as the third member of Thesis Advisory Committees. The additional members of the Thesis Advisory Committee are selected in consultation with the student's faculty adviser. All members must be approved graduate faculty as cited in the most current UCF Graduate Studies catalog. For non-thesis students, a committee of two additional faculty members will be selected in consultation with the student faculty adviser for the purposes of the oral examination. This committee must be selected by the semester prior to the semester in which the student will take the oral exam.

Research studies are required in the required courses, and at the conclusion of all course work, an assessment of students independent research projects and papers is completed. The research study will focus on reviewing and analyzing contemporary research in a students particular specialization within anthropology in order to help students acquire knowledge and skills pertaining to research-based best practices in that specialization area.

### Minimum Hours Required for M.A.-33 Credit Hours

Degree-seeking students in the anthropology program may elect to follow either a thesis or a non-thesis course of study. Both options require 33 hours of course work.

Electives will be selected in consultation with the student's faculty advisor. Students must select at least one course from each group. With prior approval, the student may take Anthropology electives other than those listed above, and may take one elective (3 credit hours) in another department. Additional electives may be selected as they become available.

### Thesis Option-6 Credit Hours

- ANG 6971 Thesis (6 credit hours)
- Successful Oral Defense of Thesis

The thesis option requires a minimum of 6 hours of thesis credit and a successful defense of a thesis. Students may enroll in thesis hours after they have successfully completed the three required courses. When a topic has been selected, students, in conjunction with their faculty adviser, will develop a thesis proposal. Copies of the proposal will be routed to members of their thesis committee and a proposal hearing scheduled. All students must pass a proposal hearing as well as a final oral defense of their thesis. Students who elect to write a thesis should become familiar with the university's requirements and deadlines for organizing and submitting the thesis. The thesis option is highly recommended for students interested in graduate work beyond the Master of Arts degree.

#### Non-thesis Option-6 Credit Hours

- Two electives in addition to the required 9 hours (6 credit hours)
- Successful Comprehensive Oral Exam

In addition to the total 15 hours of electives, the non-thesis option requires students to pass a final oral examination. The examination will be based on the course work in the student's program of study. Students must notify the department's graduate program director in writing of their intent to take the exam at least one week before the date fixed for the examination. A committee composed of three faculty members will conduct the oral examination. The grading system for the examination is as follows: 1) Pass with Distinction, 2) Pass, 3) Conditional Pass, and 4) Fail. Students who receive a grade of Conditional Pass will be required to complete additional work as determined by the grading committee. Students who fail must retake the exam. Failure to pass the examination on the second attempt will result in dismissal from the program. Students who indicate their intent to take the examination but do not take the exam will be awarded a failing grade.

## Department of Anthropology Course Addition: ANG6xxx: Proseminar in Anthropology

## Rationale for Course Addition

The Proseminar in Anthropology course will be added as a requirement that all MA students in Anthropology must take as part of their degree requirements. This course was not included in the original proposal for this degree, but there is a consensus among all faculty that it is an important course to include for our students. This course will provide a basic overview of the central concepts, theories, resources, and methods fundamental to cultural anthropology, human ecology, physical anthropology, and archaeology. This course will expose students to the inner workings of the Anthropology profession, from an academic and non-academic perspective. It will also give students an opportunity to learn about the professional side of anthropology, including professional writing, critical evaluation, constructing and evaluating grant proposals, research design, constructing CVs, and giving presentations.
