Doctor of Philosophy in Public Affairs

PROGRAM DESCRIPTION

The Doctoral Program in Public Affairs is an interdisciplinary program drawing from the strengths of faculty in Criminal Justice, Governance and Policy Research, Health Management and Informatics, Public Administration, and Social Work. The program prepares students for academic positions in colleges and universities as well as research and leadership positions in public, nonprofit and private agencies. The dynamic mix of an interdisciplinary faculty with students of varied backgrounds creates a stimulating environment to examine contemporary organizational, institutional and community problems and issues. Graduates possess the theoretical, analytical and ethical foundation to produce new knowledge that impacts policies and programs and enhances institutional and community performance.

The program creates an environment for interdisciplinary study that enhances student understanding of the myriad important and interrelated public affairs issues confronting all communities. Often, the interrelated problems of crime and justice, health services and social welfare delivery, and the administration of organizations dealing with these problems have been approached in a discipline-specific and fragmented way. The program matches career goals of students through the interdisciplinary nature of course content, the interaction with faculty from all four disciplines, and the flexibility inherent in the choice of electives. Those seeking advancement within public agencies or nonprofit organization can choose a mix of electives, including course work from other UCF programs, while those seeking to teach at the college or university level can concentrate their course work more within a single discipline.

CURRICULUM

The Doctoral Program in Public Affairs accommodates the needs of both traditional students and working professionals. All course work is offered in the evening hours and selected courses offer reduced seat time.

Students must complete 57 credit hours beyond the master's degree, including fourteen courses (42 credit hours) above the master's level distributed in the following manner:

- a five-course, 15-credit required interdisciplinary core
- a four-course, 12-credit required research methods and quantitative analysis
- a three-course, 9-credit track courses

- a two-course, 6 credit of electives, configured into a specialization component tailored to meet students' individual goals
- 15 credit hours of dissertation minimum

A maximum of 3 credit hours of Independent Study research may be used as electives with adviser's approval.

Total Credit Hours Required:

57 Credit Hours Minimum beyond the Master's Degree

The Public Affairs PhD program curriculum comprises an interdisciplinary core with advanced studies in criminal justice, health and public administration, social work, and governance & policy research. The program has a community-based focus with an emphasis on collaborative relationships across public, private and nonprofit sectors of the community.

If students receive grades of "C+" or lower in a required course, they may be dismissed from the program. Also, all students who receive a grade of "C+" or lower in a required course must repeat the course and obtain a grade of "B-" or better prior to taking the qualifying examination. A minimum of a 3.0 GPA in the specified graduate program of study is required to maintain graduate student status and for graduation.

The dynamic mix of an interdisciplinary faculty with students of varied backgrounds creates a stimulating environment to examine contemporary organizational, institutional and community problems and issues.

The mission of the Public Affairs program is to prepare future scholars and leaders to deal with complex social, health, and governance issues that cut across traditional disciplinary boundaries. The curriculum comprises an interdisciplinary core with advanced studies in criminal justice, health and public administration and social work. The program has a community-based focus with an emphasis on collaborative relationships across public, private and nonprofit sectors of the community. Graduates possess the theoretical, analytical and ethical foundation to produce new knowledge that impacts policies and programs and enhances institutional and community performance.

Proposed Governance & Policy Research Track

Policy research is an interdisciplinary study of critical issues pertaining to the accountability and impact of public and private services. As a performance-driven scientific field, numerous paradigms exist. Recently, the governance paradigm has been recognized as a main stream for solving public policy and performance problems. This paradigm is predicated upon a basic principle most clearly espoused by the Copenhagen Center (Sehested, 2003): "No single factor, public or private, has the all-encompassing knowledge, overview, information, or resources to solve complex and diversified problems" (p. 89).

The proposed track would strengthen the focus for students interested in governance and policy research issues. The core and research methods courses would be supplemented by more structured requirements for elective credits. Those students admitted to the specialty track would be required to complete three track and two electives courses. These courses all enhance their understanding and application of governance & policy research concepts and build their capacity to apply analytic techniques in preparation for completing a dissertation and conducting research in governance & public policy. The following PAF courses are to be offered as track and elective courses:

- PAF 7055 Seminar in State & Local Government Policy Research(3 credit hours)
- PAF 7510 Seminar in Policy Evaluation and Performance Measurement (3 credit hours)
- PAF 7601 Seminar in Global Governance & Policy Research (3 credit hours)
- PAF 7857 Seminar in Policy Informatics (3 credit hours)
- PAF 7XXX Advanced Seminar in Governance & Policy Research (3 credit hours)
- An appropriate methodological elective or directed independent study (3 credit hours)

"Governance and Policy Research Track" will also appear on students' degree transcripts.

The dissertations of students in the Governance & Policy Research Track will be chaired by the PAF core faculty members.

Rationale for a Governance & Policy Research Track

Under the current arrangement, students are sorted into one of five areas: health, public administration, social work, criminal justice, or "generalist." As of the Fall 2009 term, 34 students were classified in the generalist-cognate area. The area of specialization is based on students' interests and backgrounds with varying options for electives. This cognate area offers too much flexibility and does not necessitate any particular concentration or mastery of the material in governance and policy research. Articulating an explicit Governance & Public Research Track within the Public Affairs Doctoral Program has several advantages.

- A structured, policy and performance-specific component to the curriculum assures that students master key concepts in governance and public policy.
- Students will be better prepared for future careers conducting research or teaching in policy areas.

- Program graduates will have documentation of their expertise in governance and policy research.
- Course demand can be anticipated, allowing for easier course scheduling and faculty assignments.
- Closer working relationships with the core faculty members will enhance the necessary mentoring of doctoral students who are interested in governance and policy research.
- An explicit governance and policy research component in the curriculum will facilitate recruiting students from outside UCF into the Public Affairs Doctoral Program.
- A list of electives that is currently available and approved by the College of Graduate
 Studies. In addition, these courses reflect the qualification and expertise of the core faculty.

Faculty Resources

The three faculty members of the PAF core faculty are already supporting students in the governance and policy research specialty area of the Public Affairs Doctoral Program. The recruitment of a new director will certainly enhance the strength of course offerings in the proposed track. In addition, several adjunct faculty members are participating in the dissertation committees for the proposed track.

Proposed Health Services Management and Research Track

The proposed Health Services Management and Research Track is intended to provide coursework relevant to healthcare research and scholarship, and an interdisciplinary knowledge base from a healthcare perspective. The core and research methods courses would be supplemented by structured requirements for five healthcare elective credits. The track would require students to complete a total of five courses: one course is currently being taught in the Health Services Management and Research Track (HSA 7930- Healthcare Management Theories); two new doctoral level courses are proposed titled: Advanced Seminar in Health Economics (HSA 7XXX) and Advanced Seminar in Health Services Research (HSA 7XXX). Syllabi for both of the two new proposed courses are attached.

The 7000 level doctoral courses introduce students to knowledge, conceptual models, theory and analytic techniques facilitating the successful defense of dissertation and conduct of research in healthcare management and policy.

The Health Services Management and Research Track would require a total of five courses (15 credit hours) and would replace the 15 credit hours of free electives. The three 7000 level courses are:

- Healthcare Management Theories- HSA 7930 (3 credit hours)
- Advanced Seminar in Health Economics- HSA 7XXX (Attached) (3 credit hours)
- Advanced Seminar in Health Services Research- HSA 7XXX (Attached) (3 credit hours)

Students will choose two additional courses from the following masters courses, Independent Study, and other graduate courses:

- Healthcare Finance and Insurance-PHC 6160 (3 credit hours)
- Healthcare Strategic Management- HSA 6108 (3 credit hours)
- Healthcare Human Resources Management- HSA 6342 (3 credit hours)

- Health Planning and Policy- PHC 6146 (3 credit hours)
- Epidemiology- PHC 6000 (3 credit hours)
- Independent Study- HSA 6908 (3 credit hours)
- Other appropriate graduate courses approved by the Health Services Management and Research Track Coordinator (3 credit hours)

The new doctoral courses in health services management and research were designed with two aims in mind: (1) to develop student learning and competencies for healthcare scholarship and research, incorporating disciplinary knowledge in interdisciplinary contexts while building on the PAF core courses; and (2) to foster student learning in domains relevant to health services management and research in the 21st Century. Since students come with a wide-variety of backgrounds and specific interests in healthcare, the above track provides for both core competency in healthcare as well as the flexibility to develop some in-depth knowledge in particular sub-areas of our field.

The term "Health Services Management and Research Track" will also appear on students' degree transcript and the dissertations of students in the Health Services Management and Research Track will be Chaired by Healthcare Management and Informatics faculty members.

Rationale for a Health Services Management and Research Track

Under the current structure, students are sorted into one of five areas: health management and informatics, public administration, social work, criminal justice, or "generalist". This last area will no longer be supported by the program in the future. As of the Fall 2009 semester, eighteen students were specializing in the Health track.

The area of specialization does not currently necessitate any particular coursework or mastery of the material in a cognate area. In fact, students may identify themselves as specializing in the Health Services Management and Research track without ever taking a course in that field.

Articulating a specific Health Services Management and Research track within the Public Affairs doctoral Program has several advantages:

- A structured, discipline-specific component to the curriculum assures that students master key perspectives, concepts and knowledge in Healthcare.
- Students will be better prepared for future careers conducting research or education in Healthcare.
- Program graduates will have documentation of their Healthcare disciplinary knowledge and socialization as Healthcare scholars.
- Course demand can be anticipated, allowing for easier course scheduling and faculty assignments.
- Closer working relationships with healthcare management and informatics faculty members will enhance the necessary mentoring of doctoral students.
- Involving faculty with the Health Services Management and Research Track doctoral students will enhance our Department's research capacity.

Proposed Public Administration Track

The current PhD curriculum includes 15 credit hours of interdisciplinary core courses, 12 credit hours of research methodology courses, 15 credit hours of free electives, and 15 credit hours of dissertation research. The proposal for a track in Public Administration would maintain the 15 hours of Interdisciplinary Core Courses, the 12 hours of research methods courses, and 15 hours of Dissertation. The 15 credit hours of core electives will be taken from the PA track courses.

The term "Public Administration Track" will also appear on students' degree transcript and the dissertations of students in the Public Administration Track will be chaired by Public Administration faculty members.

The Public Administration Track integrates the historical evolution of the public administration field, the current challenges in theory and practice in our increasingly inter-connected society, and the future directions needed as a discipline and society to achieve responsive solutions to complex public problems. The proposed track in Public Administration would strengthen the focus for students interested in public policy, administration, and management issues.

Rationale for the Proposal

Under the current arrangement, students are sorted into one of five areas: health management and informatics, public administration, social work, criminal justice, or "generalist public affairs." As of the Fall 2009 term, 22 students were specializing in public administration. The area of specialization is based on students' interests and backgrounds. Area of specialization does not, however, necessitate any particular course work or mastery of the material in a cognate area. Students may, in fact, identify themselves as specializing in public administration without ever taking a course in that discipline. Articulating an explicit Public Administration within the Public Affairs Doctoral Program has several advantages.

- The first reason to recommend proceeding with our proposal is to allow our students who have an interest in public administration to obtain a firm foundation in our discipline.
- A structured, discipline-specific component to the curriculum assures that students master key concepts in public administration.
- Students will be better prepared for future careers conducting research or teaching in public administration.
- Program graduates will have documentation of their expertise in public administration.
- Course demand can be anticipated, allowing for easier course scheduling and faculty assignments.
- Closer working relationships with public administration faculty members will enhance the necessary mentoring of doctoral students.
- Involving with the doctoral students will enhance our department's research capacity.

- The Center for Public and Nonprofit Management (CPNM) will provide research funding opportunities for the Public Administration Track students.
- An explicit public administration component in the curriculum will facilitate recruiting students from outside UCF into the Public Affairs Doctoral Program. The national ranking of the Department will also help recruiting doctoral students to the program.

Each student would be required to take the five courses below and the courses would be offered once every two years:

PAD 7026 Advanced Seminar in Public Administration

Course Description: This doctoral seminar explores the dominant themes in public administration since the founding of the United States, as expounded by some of the field's leading thinkers (e.g., Max Weber, Woodrow Wilson, Herbert Simon, Dwight Waldo) and provides an overview of the growth and development of public administration as a field of inquiry. It covers the historical and theoretical dimensions of public administration, including New Public Administration, New Public Management, and addresses a number of core issues in contemporary public administration (i.e. networks, collaborations, and performance). In the context of the historical review of public administration and its reforms, the course will address features of administration including: primary theoretical and epistemological foundations, prevailing rationality and associated models of human behavior, conception of the public interest, to whom public administrators are responsive, the role of government, the role of citizens, and the approach to accountability.

PAD 7XXX Advanced Public Management

Course Description: This course is designed for Ph.D. students in the Public Affairs program with a public administration concentration. The course examines the latest literature and practice in the field of public organizational management. It focuses on empirical findings and theoretical discussions in key public management areas of executive management, organizational behaviors, public budgeting, human resource management, policy design/implementation/evaluation, and sustainability management. The course should guide students develop a focused area of study prior to their dissertations.

PAD 7XXX Program Design and Management

Course Description: This doctoral course provides students with advanced organizational design and development theories and management techniques utilized in designing and developing public and nonprofit programs. Inherent in the process is the design, development, implementation, management, and evaluation of these programs, which are increasingly being implemented and administered by public and nonprofit managers. This course also integrates theory and practice into the development of grant projects, grant proposals, grant applications, grant selections, and grants management and oversight from the perspective of both the funder and the fundee.

PAD 7XXX Collaborative Public Management

Course Description: This doctoral seminar introduces students to the theory, skills, and processes of designing, developing, evaluating, and managing networks in a public management setting. Public managers must learn to build critical linkages in building capacity across organizational and sectoral boundaries while simultaneously managing the internal functions of their organizations. Public policies are often designed and implemented through networks as structures involving multiple actors (nodes) with multiple linkages through which public goods and services are planned, designed, produced, delivered, and evaluated. At all levels of government and in each sector, public managers require a different and more complex approach to management than the traditional notions of hierarchy and command and control structure.

PAD 7XXX Advanced Research in Public Administration

Course Description: The purposes of this course include: 1) to provide a capstone experience, which integrates doctoral level knowledge and skills gained from previous coursework on public administration; 2) to provide an opportunity for doctoral students to share research methodology and findings with fellow students and faculty; and 3) to receive feedback to assist in future research endeavors. The framework of the course will be based upon the components of a traditional dissertation, with emphasis given to literature review, theory building, data collection, and data analysis.

Proposal for a Social Work Track within the Public Affairs Doctoral Program

The Existing Public Affairs Doctoral Program

The doctorate in the Public Affairs program at the University of Central Florida provides a unique focus on public policy, planning, and administration. This interdisciplinary program draws from the strengths of faculty in four disciplines (Criminal Justice, Health Management Informatics, Public Administration, and Social Work) in its preparation of graduates for academic positions in colleges and universities as well as research and leadership positions in public, nonprofit and private agencies. The dynamic mix of an interdisciplinary faculty with students of varied backgrounds creates a stimulating environment to examine contemporary organizational, institutional and community problems and issues.

The mission of the Public Affairs program is to prepare future scholars and leaders to deal with complex social, health, and governance issues that cut across traditional disciplinary boundaries. The curriculum comprises an interdisciplinary core with advanced studies in criminal justice, health and public administration and social work. The program has a community-based focus with an emphasis on collaborative relationships across public, private and nonprofit sectors of the community. Graduates possess the theoretical, analytical and ethical foundation to produce new knowledge that impacts policies and programs and enhances institutional and community performance.

The current curriculum includes 15 credit hours of interdisciplinary core courses, 12 credit hours of research methodology courses, 15 credit hours of free electives, and 15 credit hours of dissertation research. These requirements are listed below.

Proposed Social Work Track

The proposed 15-credit hour social work track is intended to provide coursework relevant to social work research and scholarship, and an interdisciplinary knowledge base from a social work perspective. The core and research methods courses would be supplemented by structured requirements for elective credits. The track would require students to complete four social work courses; one existing 6000-level course (SOW 6399) and three new 7000-level doctoral courses, introducing them to knowledge, conceptual models, theory and analytic techniques facilitating the successful defense of dissertation and conduct of research in social work. The remaining three credit hours are open to any graduate level coursework relevant to the student's dissertation focus. The following courses would replace the 15 credit hours of free electives:

- SOW 7xxx Conducting Evidence-based Research in Social Work and Allied Fields (3 credit hours)
- SOW 7xxx Theory Development in Social Work and Applied Social Science Research (3 credit hours)
- SOW 7xxx Social Entrepreneurship in the Public and Social Sectors (3 credit hours)
- SOW 6383 Social Work Administration (3 credit hours)
- An appropriate methodological or substantive elective (3 credit hours)

The new doctoral courses in social work were designed with two aims in mind: (1) to develop student learning and competencies for social work scholarship and research, incorporating disciplinary knowledge in interdisciplinary contexts, building on the PAF core courses, (2) to foster student learning in domains relevant to social work research in the 21st Century; namely through the understanding and application of concepts and tools in knowledge translation, through the evidence-based research course, social innovation through the social entrepreneurship course, and model building and testing through the theory course. Social work research in the 21st century is informed by knowledge-based considerations of diversity in a pluralist society, disparities, globalization, interdisciplinary collaborations, networks, technology, ethics and social justice. These themes are woven through the social work track courses and ground students in key contextual factors in the design, conduct and dissemination of social work research. The advanced administration course provides a situated view of social work knowledge and concepts as decision support tools, as the theoretical and empirical bases for administrative work, and as metrics for social welfare assessment and evaluation.

"Social Work Track" will also appear on students' degree transcripts. The dissertations of students in the Social Work Track will be chaired by Social Work faculty members.

Rationale for a Social Work Track

Under the current structure, students are sorted into one of five areas: health management informatics, public administration, social work, criminal justice, or "generalist;" although this last area will no longer be supported by the program, and its students are now advised by faculty members in the other four areas. As of the Fall 2009 semester, four students were specializing in social work. The area of specialization is based on students' interests and backgrounds. Specialization in the social work cognate does not, however, require the development of a social work knowledge base or social work research competencies. In fact, the existing social work cognate does not require taking a course in that discipline. There are several advantages to mounting a social work track:

- A structured, discipline-specific component to the curriculum assures that students master key perspectives, concepts and knowledge in social work.
- Students will be better prepared for future careers conducting research or education in social work.
- Program graduates will have documentation of their social work disciplinary knowledge and socialization as social work scholars.
- Course demand can be anticipated, allowing for easier course scheduling and faculty assignments.
- Closer working relationships with social work faculty members will enhance the necessary mentoring of doctoral students.
- A defined social work component in the curriculum will facilitate recruiting students from outside UCF into the Public Affairs Doctoral Program.

Rosen College of Hospitality Management

Graduate Certificate in Hospitality Management

Introduction:

The Rosen College of Hospitality Management is proposing a Graduate Certificate in Hospitality Management. The certificate program is consistent with and assists in meeting two key objectives expounded in the Mission Statement of University of Central Florida (UCF): (1) 'providing high quality, broad-based education and experience-based learning; and (2) 'highly relevant continuing education and public service initiatives that address pressing local, state, national, and international issues in support of the global community'.

The certificate program will also advance UCF's international prominence by targeting post-baccalaureate students from outside the United States. An experiential learning portion of the program is to be offered in collaboration with the Walt Disney World Resort, and will reinforce UCF's image as a leading partnership university.

The proposed program will incorporate both classroom and experiential learning components. Students will take cutting-edge classes from leading educators in the field of hospitality and tourism, and participate in a structured internship with the world's foremost entertainment company. The combination is a strong value proposition for attracting the targeted international student population that is further enhanced through the co-branding of UCF with Walt Disney World. Successful completion of the certificate program will greatly enhance the positioning of the graduates to become leaders in the tourism industry in their home countries.

Considering that the hospitality and tourism industry is the world's second largest employer (after healthcare), this program would enable UCF to develop off-shore partnerships with our local constituents who are expanding their operations globally. The Walt Disney Company has one new international venture (Shanghai), Universal has two (Singapore & Dubai), and SeaWorld envisions four (all in Dubai). By providing graduate education to an international audience, the Rosen College would help UCF gain global recognition while enhancing its stature as a partnership university.

Demand Potential:

Despite the current economic climate, it is anticipated that the demand for travel will become more robust as the economy rebounds. For China alone, a six-fold increase in outbound travel is forecast for the next five years. As the hospitality and tourism industry develops to meet new global demand, the need for educated managers will grow. This will be exacerbated by the fact that the Generation X population is significantly smaller than the Baby Boom generation,

resulting in a dearth of management talent to meet the increased number of available positions as the Baby Boomers begin to retire or work fewer hours.

A large population of college graduates worldwide would benefit from this certificate program. These are individuals with degrees in general business, hospitality and tourism, and related-fields of study. The proposed certificate would position these graduates for managerial roles in the hospitality and tourism industry. The program would further act as a 'teaser' for participants by showcasing elements of the M.S. in Hospitality Management program, and is anticipated to be a driver for applications to master's degree programs.

The certificate program builds upon and further enhances a very successful UCF/WDW continuing education model that only awarded Division of Continuing Education (DCE) Certificates of Completion. The original program has ended, but approximately 1,000 international students participated in the program each year for the past two years. Student credit hours earned in this program may be accepted toward a graduate degree program, at the consent of the program.

The number of students entering the initial program offering is projected to be relatively small. The first program is targeted to begin in Summer 2010, and is expected to attract 35 to 45 participants. The number of elective courses offered is anticipated to expand with a growth in participants, further broadening the appeal of the certificate program. The duration of the program is six months, and there is a potential for four intakes per year.

Participants in the program will have completed their bachelor's degree. These graduates will be interested in the certificate program because it is designed to increase their career choices and opportunities for employment in the growing field of hospitality and tourism.

As direct result of the DCE program that has been in effect for the past three years, we have identified strong pockets of interest for targeted, niche programs. In addition, institutions in Singapore have met with the Rosen College seeking to develop collaborative programs because of Universal's opening there in 2010. Taiwan universities also have indicated a strong interest in our programs. We have had great success with the Universities in Brazil and a graduate certificate program will likely intrigue them. Based on our recent experiences, there is great potential for further collaboration with the universities with which we already have student exchange programs in the United Kingdom, France, Austria, and Japan.

Courses:

The Graduate Certificate Program will consist of twelve credit hours/four courses. The courses will be selected from existing graduate course offerings in the UCF Master's in Hospitality and Tourism Management program. Each cohort will have the same two required courses, but the remaining two 'elective' courses will be selected from a larger pool of courses to address differences in participant backgrounds and/or interests. The courses will be taught by

Rosen College Graduate Faculty and are further proposed to be taught in a mixed 'M' delivery mode.

Course offerings

This 3 CR HR course is a critical experiential component of the certificate program, and provides a formal structural component. It will be developed and administered in cooperation with the UCF Cooperative Education and Experiential Learning Office

Other classes may be added upon recommendation by Rosen College Graduate Faculty and upon review by the Graduate College.

The program director, in consultation with the department chairs, will select, at the least, two elective courses for each cohort. Once cohorts reach optimal size, more than two electives are expected to be available, and students in a cohort will then self-select two from those offered.

Graduate faculty status in the Rosen College is required for teaching in the certificate program. Attached is the current list of Rosen College graduate faculty. Course assignments will be made by the Rosen College department chairs. Faculty are projected to be compensated under the UCF Dual Compensation policy, as certificate course assignments are expected to be beyond their existing course loads.

Funding:

Participants of this program will pay fees, at the least, equivalent to in-state graduate tuition. Further fees may be charged to offset additional administrative program costs. The certificate program will be fully self-funded, and no E&G funds will be used in support of the program. As the attached budget projects, all expenses will be covered by the program fees. However, to keep the program competitive with other similarly targeted programs, costs and resultant participant fees should not exceed \$3,800.00 per program participant. This is substantive increase above the terminated DCE program cost of \$2,200 per participant.

Since no E&G funding will be used, it is requested that program fees be collected through UCF DCE and be accounted for through auxiliary accounts per current UCF policies and procedures. The funds will be distributed through auxiliary accounts based on budgets developed and approved by the Rosen College program director. Consistent with current UCF procedures, all other budget approvals will be secured.

Attached are the Program Recommendation Forms for temporary suspension of the Ph.D. in Economics and the MS in Economics. The Masters Program Review Committee voted to abstain from considering the temporary suspension. As noted in the attached MPRC minutes, the committee felt consideration of a motion to suspend was outside their purview. The Doctoral Program Review Committee did not support the suspension of the PhD program. Due to a tie vote, the motion to suspend the PhD program did not pass.

Teach out plans for current students are attached to the program recommendation forms. All MS students will complete course work by Spring 2010 or Summer 2010. All but 1of the doctoral students will have either completed their course work by Spring 2010 or will be leaving the program. The one remaining student will qualify for a MS in Economics by the end of the Spring 2010 term. The College will continue the student's financial support for Summer 2010 if required. The Economics Department will also assist her with placement at another university if she wishes to continue her graduate training.

Minute, Masters Programs Review Committee, November 9, 2009

The meeting was called to order at 4:04 PM in Room 301, BA II. In attendance were Jim Gilkeson, Amit Joshi, Daniel Tzabbar, Charlie Kelliher, Mark Soskin (chair), and Foard Jones (Asst. Dean).

The first order of business was consideration of the College of Business suspension of the Masters Degree MS program in Economics. This action resulted from deliberations by a special ad hoc committee formed by the CBA Dean at the request of the Provost. File copies of the College of Graduate Studies Program Recommendation Form for suspending programs and an Excel file copy of current enrollments in the program were both emailed to MPRC members at least a week in advance of consideration, in accordance with MPRC policy.

Dr. Gilkeson made the following motion: "The MPRC abstains because the Committee interprets the suspension process of the MS in Economics by the College to not lie within MPRC's purview of considering curricular and programmatic structure." After the motion was seconded and discussed, it passed by a vote of 3-2.

Under other business, Dr. Jones urged Committee action on two catalog items emailed to members this past summer. The first issue dealt with the Business Post-Bac included in the online application of the Catalog. Dr. Jones expressed concern that applicants could possibly infer this to mean the existence of a program. It was pointed out that the MBA no longer offers 5000-level courses in its degree program, so there is no need for Post-Bac student status in this program. Dr. Kelliher, however, pointed out that MSA and MST programs in the School of Accounting still make use of 5000-level courses. It was determined, though, that Accounting did not need its Masters Degree students to be admitted or designated by Business Post-Bac. The Committee unanimously voted to remove all reference to "Business Post-Bac" from the catalog.

The second item of concern raised by Dr. Jones was with the 4-years-to-completion rule applicable to the MBA degree. Phase-in implementation of the major revisions associated with the Lock Step MBA will soon be reaching this 48-month point for the initial class of students. Following discussion, the Committee unanimously voted to let students who exceeded their 4 years to deal with time extension needs by using the existing petition process, rather than having the Committee either lengthen the 4-year limit or establish any new appeal procedure.

The Committee meeting was adjourned at 4:30PM.

The College of Arts and Humanities requests that the existing MFA in Film and Digital Media be "split" into two (2) separate MFA degrees and that the existing MA in Film and Digital Media be revised to delete the reference to "film" in the degree title.

Background: Effective Academic Year 2010-2011, the Departments of Art and Digital Media will merge to form the new School of Visual Arts and Design (SVAD). The establishment of the new school was approved at the November 2009 BOT meeting. The restructuring is in direct response to the internal academic program review process and necessitates some curricular "housekeeping" since the Department of Film will remain a separate unit outside of the school. Specifically, both MA and MFA degree titles refer to a school that no longer exists, the School of Film and Digital Media.

Rationale: The revision of the existing MA and MFA in Film and Digital Media would not only reflect the new administrative structure in place for the 2010-2011 academic year but would also "officially" separate two departments (Film and Digital Media) that have functioned independently for several years following the dissolution of the "old" School of Film and Digital Media. The requested changes would allow a streamlined transfer of Digital Media's degree offerings to the School of Visual Arts and Design once the department is dissolved and the new school goes into effect.

Since both departments currently maintain separate budgets, faculty, and curricula, there is no impact to these resources. Additionally, there is no detrimental effect to current—or future—students in either the existing MA or the MFA in Film and Digital Media since admitted graduate students within each department may be easily identified through the tracks they pursue. Simply stated, the requested division can be accomplished neatly to eliminate confusion.

Sub-plan - Curriculum:

During the first academic year, students take required courses as dictated by the student's plan of study and electives suggested by their adviser. The coordinator is also the adviser for all thesis students until a Digital Media faculty mentor agrees to work with the student. The faculty mentor then becomes the student's graduate adviser.

- DIG 6550 Digital Media Pre-Production (3 credit hours)
- DIG 6971 (6 credit hours)

Each candidate for the Master of Arts submits a thesis prospectus and preliminary bibliography on a topic selected in consultation with the adviser. The formal thesis is initiated by the preparation of a proposal that meets both departmental and university requirements for the thesis. Prior to enrollment into thesis credit hours, the adviser, in consultation with the student, designates a Thesis Committee to be further approved by the College Graduate Dean. This committee is chaired by the adviser and includes two or more additional faculty members from the Department of Digital Media.

The members of the student's thesis committee judge the proposal as the preliminary step to beginning the thesis. This committee must approve the Thesis Proposal before academic credit can accrue.

The thesis is a formal written document. The introduction cites similar, related, and antecedent work. The body explains the purposes of the project, the method of its production, and any evaluation that was performed. The conclusion includes plans for future work. The thesis also includes an archival copy of the resulting creative product. Both the thesis and the creative product must be delivered in digital form, acceptable by the UCF library according to its standards for digital dissertations and theses.

Thesis Defense

In addition to a written thesis, the final step in completing the thesis requirement is an oral defense before the thesis committee. Candidates must present their creative or research work and explain its creation in an oral defense. These presentations are made to the student's committee in a public meeting that other faculty and students may attend.

Nonthesis Option—15 Credit Hours

Students selecting the nonthesis option are required to complete 6 additional credit hours of required courses and 9 credit hours of electives:

- DIG 6938 Theory and Application of Interactive Performance (3 credit hours)
- DIG 5565 Digital Asset Management (3 credit hours)

· Electives (9 credit hours)

Many graduate-level courses in the College of Arts and Humanities can be used as electives, based on an adviserapproved plan of study. In addition, other graduate courses may be used in place of those listed above, with permission of the adviser. These courses must be selected so as to ensure that at least one-half of the courses in the student's plan of study are taken at the 6000 level.

Comprehensive Examinations

Digital Media MA students must take a Comprehensive Examination. The process is designed to evaluate both the students' basic knowledge and competencies, and their ability to synthesize and apply what they know in depth—that is, both the breadth and depth of student learning in the Program. It is not intended to test specific course content for which students have already been evaluated and graded. The exam is designed to test the student's ability to respond and substantiate the response in a professional and educated fashion.

The Comprehensive Examination consists of five general categories. Students answer four questions in a total maximum time of four hours. Students will be given the opportunity to select one question from any four of the five categories, i.e. 1. Technology and Theory: development, effects, uses; 2. Media history: New media, cinema, television;

Independent learning:

Students who elect the thesis option engage in independent learning through the design and implementation of original research in the thesis process. Students who pursue the comprehensive exam option experience independent learning through their individual preparation for comprehensive exams. All students engage in independent learning in every Digital Media core course. A research paper or project is required in each of these classes. The papers and projects provide independent learning by requiring students to design and carry out research projects and develop analytical papers, some of which are submitted to conferences and/or journals for peer review. Internships and independent studies are also common opportunities for independent learning in the Digital Media MA Program.

The Master of Fine Arts in Film and Digital Media offers a Visual Language and Interactive Media track designed to educate the next generation of filmmakers and media entrepreneurs and produce artists, entrepreneurs, educators, engineers, and scientists who use digital technologies to create content in many venues (film, digital media, interactive entertainment, and a host of others), and who will develop and use digital technologies in new ways.

SubPlan Description:

The Master of Fine Arts in Visual Language and Interactive Media Track is a specialized program designed to train degree candidates to learn and implement the conceptual, design, and technical skills needed for twenty-first century storytelling. The principal emphasis of the program is on the creation of compelling content for new media for which production tools and processes are currently being invented. These students pursue a variety of goals addressing media convergence: including film, digital, and dynamic media skills, extending these skills into new areas, or in the case of educators and media professionals, expanding their expertise and credentials for use in their professions. Students may be admitted on either a full-time or part-time basis, through full-time participation is recommended.

The program is based on an apprenticeship model. Students explore new media under the guidance of a faculty member and collaborate with this faculty member in creative and research projects that foster a unique contribution characterized as innovative in approach. This degree program builds on undergraduate knowledge to build a mature set of conceptual, design, and technical skills needed to communicate stories and messages in a single discipline or in an interdisciplinary environment. An eighteen-hour thesis project is required. A typical thesis might involve designing content that is imparted through integrating traditional media with computer-based and computer-enhanced formats where the content is enriched by the use of novel interactive modalities and techniques. Work in the thesis will extend the capabilities of interfaces and measure the effectiveness of training and communicating.

This MFA track is embedded in a rich environment of film and digital media work at UCF and in the surrounding community. The following are active areas of work at UCF:

The Department of Digital Media faculty have extensive professional and academic experience in areas spanning film, video, multimedia, interactive and web design, human-centered interactive design, exhibition and theme park design, simulation and training, game development, broadcast design and motion graphics, animation, visual language, immersive design environments, database design, e-commerce, digital storytelling, and educational technology and community development.

Students desiring admission to the Visual Language and Interactive Media track should have an undergraduate degree in a media-related creative or technical field such as art, film,

animation, theater, music, digital media, computer science, English, or education in the arts. Students will be admitted on the basis of a portfolio review or compelling plan of action for the creation of new knowledge in a profession or field of study by the addition of Digital Media. Desirable background skills for this degree include computer and software literacy. Examples include mastery of Mac or PC workstations that are configured with a diverse range of hardware and software for multimedia production.

Sub-plan - Curriculum:

Visual Language and Interactive Media MFA track requires a minimum of 60 credit hours including a thesis project. The program requires 32 required credit hours, 18 program elective credit hours, and 10 credit hours of thesis.

During the first academic year, the student pursues required courses as dictated by the student's plan of study. Throughout the second year, the student finishes remaining required course work and enrolls in electives approved by his or her thesis chairperson/adviser. During the third year, the student's focus is on completing his or her thesis work.

A Visual Language and Interactive Media MFA thesis project involves creating innovative applications of digital media to serve artistic, entertainment, commercial, and/or educational needs. The thesis consists of three parts: (1) the creative project (that utilizes digital media); (2) the production journal (documenting the process of developing the project and evaluating its effectiveness); and (3) dissemination (the work is submitted in a juried exhibition, a refereed publication, or other venue that demonstrates development in connection with a professional partner).

The production journal portion of the thesis a formal written document. The introduction cites similar, related, and antecedent work; the body explains the purposes of the project, the method of its production, and any evaluation that was performed; and it concludes with plans for future work. The thesis will also include an archival copy of the resulting creative product. Both the thesis and the creative product must be delivered in a digital form, acceptable by the UCF library according to its standards for digital dissertations and theses.

Thesis Defense

In addition to the creative project, the written thesis, and dissemination of work, the final step in completing the thesis requirement is an oral defense before the thesis committee. Candidates present their creative or research work and explain its creation in an oral defense. These presentations are made to the student's committee, in a public meeting that other faculty and students may attend.

The ideal MFA student is an imaginative, visual storyteller and inventive problem-solver who is interested in exploring digital cinema and the intersection of art and commerce utilizing real world applications. They are independent thinkers willing to inspire others and nurture a project from vision to distribution. These programs are designed to educate the next generation of filmmakers and media entrepreneurs and produce artists, entrepreneurs, educators, engineers, and scientists who use digital technologies to create content in many venues (film, digital media, interactive entertainment, and a host of others), and who will develop and use digital technologies in new ways.

The Master of Fine Arts in Entrepreneurial Digital Cinema Track is designed for individuals who intend to work directly on the creation of new films and other media products and prepares graduates to teach in colleges and universities. This rigorous, three-year professional program is for visual artists and practitioners who demonstrate exceptional artistic and intellectual prowess and evidence of significant professional promise. The MFA degree produces graduates with mastery of storytelling while allowing for individualized specialization. Upon completion, each student will have produced a micro budget Digital Feature Film and prepared a marketing strategy for its distribution. The degree seeks to develop entrepreneurial, cinematographic storytellers of the highest quality by providing a select number of graduate students with the education and experience of creating strong visual narratives worthy of critical attention, professional recognition, and exhibition. This is a creative program in which students develop their own unique artistic voices and visions, the hallmarks of the personal film. We encourage a spirit of inquiry, creative exploration, and artistic leadership in the application of cinematic languages to new technologies.

This program requires that students take GEB 6115 Entrepreneurship, taught by the College of Business Administration; and they may take other electives. This gives students access to courses that will enhance the skills needed to finance and market their future projects.

The Master of Fine Arts in Visual Language and Interactive Media Track is a specialized program designed to train degree candidates to learn and implement the conceptual, design, and technical skills needed to create and communicate twenty-first century stories and messages. The principal emphasis of the program is on the creation of compelling content for new media for which production tools and processes are currently being invented. These students pursue a variety of goals addressing media convergence: increasing film, digital, and dynamic media skills, extending these skills into new areas, or in the case of educators and media professionals, expanding their expertise and credentials for use in their professions. Students may be admitted on either a full-time or part-time basis.

The program is based on an apprenticeship model. Students explore new media under the guidance of a faculty member and collaborate with this faculty member in creative and research projects that foster a unique contribution characterized as innovative in approach. This degree program builds on undergraduate knowledge to build a mature set of conceptual, design, and technical skills needed to communicate stories and messages in a single discipline or in an interdisciplinary environment. An eighteen hour thesis project is required. A typical thesis might involve designing content that is imparted through integrating traditional media with computer based and computer enhanced formats where the content is enriched by the use of novel interactive modalities and techniques. Work in the thesis will extend the capabilities of interfaces and measure the effectiveness of new ways of telling stories and conveying messages.

This Visual Language and Interactive Media MFA track is embedded in a rich environment of film and digital media work at UCF and in the surrounding community. The following are active areas of work at UCF:

- Digital media in instructional applications
- Experience design Interactive performance
- Sound and music design

Cultural heritage preservation using new media

The School-Department of Film and Digital Media faculty have extensive professional and academic experience in areas spanning film, video, multimedia, interactive and web design, human-centered interactive design, exhibition and theme park design, simulation and training, game development, broadcast design and motion graphics, animation, visual language, immersive design environments, database design, e-commerce, and educational technology and community development.

Students desiring admission to the Visual Language and Interactive Media Track should have an undergraduate degree in a media-related creative or technical field such as art, film, animation, theater, music, digital media, computer science, English, or education in the arts. Students will be admitted on the basis of a portfolio review or compelling plan of action for the creation of new knowledge in a profession or field of study by the addition of Digital Media. Desirable background skills for this degree include computer and software literacy. Examples include mastery of Macintosh and PC workstations that are configured with a diverse range of hardware and software for production and editing of images and sound for stories and messages.

Sub-Plan Description Brief:

The Master of Fine Arts in Film and Digital Media offers an Entrepreneurial Digital Cinema track to prepare students for jobs in the emerging world of digital motion pictures as educators, filmmakers and as business people. The program requires each student to complete a feature length film as a thesis project.

SubPlan Description:

The Entrepreneurial Digital Cinema track provides students with a unique education in the theory and practice of low budget (i.e. < \$50K) digital motion picture production; training students in conceptual and theoretical skills through class work, research and the production of a feature length motion picture.

In addition to an education in the crafts of digital filmmaking (from screenwriting through postproduction and marketing), the program aims to train entrepreneurs and educators. Class and independent research work educates students in the theory and practices employed by filmmakers in storytelling; how entrepreneurial filmmakers capitalize, manage and sell their work; and how a production team working on a digital motion picture achieves artistic goals.

The program requires that students take GEB 6115 Entrepreneurship and GEB 6116 Business Plan Formation, taught by the College of Business Administration, and encourages students to take courses in other departments that will enhance the skills needed to write, refine, develop, finance and market their future projects.

Sub-plan - Curriculum:

The MFA track in Entrepreneurial Digital Cinema requires a minimum of 60 credit hours, including 15 core credit hours, 21 credit hours in the area of specialization, 6 elective credit hours, and 18 credit hours devoted to the thesis project.

Before undertaking the thesis project, candidates must meet with the thesis advisory committee to submit and discuss the proposed project and obtain the committee's approval. The thesis requires intensive applied learning in order to complete a feature length project. Additionally, the thesis project has a strong research component both in the initial development phase and in the creation of the distribution and marketing plan for the project. The final stage of the curriculum serves as a bridge to the professional world and supports the entrepreneurial philosophy of the program. The thesis project must be reviewed by the faculty adviser throughout the production process, and meet agreed upon criteria within a stated time frame. Once the thesis project is completed, candidates must have a screening or exhibition of the work, and meet with the thesis advisory committee for final approval and oral defense.
