Dr. Bryer is nationally recognized and has over two dozen peer review articles and chapters dealing with government-citizen relations, bureaucratic responsiveness, collaborative governance, and citizen engagement. Dr. Bryer will be overseeing the *Practicum in Community-Based Research* course,

Mary Ann Burg received her Ph.D. in Sociology as well as a Masters in Social Work and is an associate professor in the School of Social Work at UCF. Dr. Burg has dozens of peer reviewed articles and has been involved in several federally funded research studies in the areas of quality of life for cancer survivors, curriculum outcomes for social work, access to psychosocial care in health care settings, and health professional's training.

Latarsha Chisholm received her Ph.D. in Health Services Research and is an Assistant Professor in the Department of Health Management & Informatics at the University Central Florida. Her research interests include aging, quality and outcomes, healthcare disparities, and organizational theories. She also completed a National Research Service Award (NRSA) postdoctoral fellowship in Health Services Research at the University of North Carolina-Chapel Hill. Dr. Chisholm will be responsible for teaching the *Program and Policy Evaluation for Public Affairs*.

Lynette Feder has a Ph.D. in Criminal Justice and is the Director of the Public Affairs doctoral program and professor at UCF. Dr. Feder has been nationally recognized for her experiments studying issues related to mother and children's health. She has more than two dozen publications that cross disciplinary boundaries and has received several federal grants to conduct evaluations of highly publicized interventions and preventive programs. Dr. Feder will be responsible for teaching the Advanced Research Methodology for Public Affairs and team teach (along with Dr. Martin) the Foundations of Public Affairs: People, Places, Policies, and Paradigms courses.

Jacinta Gau has a Ph.D. in Criminal Justice and is an assistant professor in Criminal Justice at UCF. Dr Gau has published over two dozen peer-reviewed articles, chapters, and books. Her research interests include policy-community relations, community perceptions of police, and procedural justice and policy legitimacy. She recently published a statistics book and will be teaching the Advanced Statistics for Public Affairs II: Survey of Statistical Methods course.

**Naim Kapucu** has a Ph.D. in Public and International Affairs and is a professor in the School of Public Administration and the Masters of Public Administration Coordinator at UCF. The doctoral program in Public Affairs (PAF) is different from most other doctoral programs in that it was always set up to be an interdisciplinary degree. As such, there are currently 9 courses within the PAF program that all PAF students are required to take. Additionally, students must take another three (or four depending upon the track) required courses within the track. They are then left with the ability to take one or two (again depending upon the track) electives. None of the track requirements or electives are changing at this time – only the courses within the PAF requirements which will take it from 9 PAF required courses (for a total of 57 credits post-Masters) to 10 required courses (and 60 credits post-Masters). Of these nine current courses, five will be revised (see below) and four will be removed and replaced with five new courses. The specific changes include:

#### Revised Courses:

#### PAF 7000. Foundations of Public Affairs: People, Places, Policies & Paradigms

3(3,0). PR: Admission to PhD Program or C.I. Introduction to Public Affairs — with special emphasis on the interrelationships among criminal justice, health services administration, public administration and social work. The course provides an overview of public affairs and is taught from an interdisciplinary perspective focused on the necessary components to effectively address community-based problems

#### PAF 7230. Strategic Change and Management for Public Affairs

3(3,0). PR: Admission to Ph.D. Program or C.I. <del>Traditional organizational behavior in public affairs within the context of public agency interests and the demand for organizational change This course deals with change in: organizations, governance relationships and communities. The course uses a "tools" approach.</del>

#### PAF 7802. Advanced Research Methods in Methodology for Public Affairs

3(3,0). PR: Admission to PhD Program or C.I. Advanced social science methodology. Critical evaluation of research; the design and conduct of research. A solid background in research methodology is required Course focuses on the nature and process of scientific inquiry including specific methods for conducting community-based interdisciplinary research.

PAF 7804. Advanced Quantitative Methods I Advanced Statistics for Public Affairs I: Multivariate Analysis

3(3,0). PR: Admission to PhD Program or C.I. An investigation of data analysis strategies, including presentation of results, building upon knowledge of hypothesis testing and multivariate statistics. An advanced statistical course that develops expertise in performing geographic information analysis, research syntheses, meta-analyses and economic analysis such as cost effectiveness analysis.

# PAF 7805. Advanced Quantitative Research Methods in Public Affairs II Advanced Statistics for Public Affairs II: Survey of Statistical Methods

3(3,0). PR: PAF 7804- & Admission to PhD Program or C.I. Advanced principles and methods employed in PAF applied research. Emphasis on application of structural equation modeling techniques/research methods to the development of causal models. Introduction to an array of statistical modeling techniques for different types of data and research designs. Coverage of theory and application of each technique.

#### **Dropped Courses:**

#### PAF 7110. Ethics and Social Justice in Public Affairs

3(3,0). PR: Admission to PhD Program or C.I. Basic philosophical principles of theories as they impact practitioner level ethical demands for managers; the examination of public policy institutions shaping social justice in U.S.

#### PAF 7315. Public Policy: Microeconomic Applications

3(3,0). PR: Admission to Public Affairs Ph.D. program or C.I. This is a public policy course that uses microeconomics as a tool for analysis.

#### PAF 7300. Policy Analysis in Public Affairs

3(3,0). PR: Admission to PhD Program or C.I. Public policy development and impact analysis in criminal justice, health administration, public administration, and social work.

#### PAF 7806. Advanced Research Methods in Public Affairs II

3(3,0). PR: PAF 7802. Advanced critical evaluation of research methods that concentrate on key concepts and procedures. A variety of methodologies will be used with a focus on the strengths and weaknesses of various research strategies

## PAF 7XXX. Social Inquiry and Public Policy

3(3,0). PR: Admission to PhD Program or C.I. Course examines the philosophical foundations of social inquiry and the importance of theory in public policy and evaluation research. The course addresses the use and usefulness of social sciences in informing public policy.

<u>3(3,0)</u>. PR: Admission to PhD Program or C.I. Course is an overview of qualitative research methods and their application in interdisciplinary and mixed methods' community-based public affairs' research.

3(3,0). PR: PAF 7802 & Admission to PhD Program or C.I. Course is designed to use empirical information to assess the effectiveness of policies and programs in public and nonprofit settings.

#### PAF 7XXX. Advanced Statistics for Public Affairs III: Continued Survey of Statistical Methods

3(3,0). PR: PAF 7805 & Admission to PhD Program or C.I. . An advanced statistical course that develops expertise in performing geographic information analysis, research syntheses, meta-analyses and economic analysis such as cost effectiveness analysis.

#### PAF 7XXX. Structural Equation Modeling

3(3,0). PR: PAF 7805 & Admission to PhD Program or C.I. . Course introduces advanced methods that include causal thinking, predictor tree analysis, propensity score matching and analysis, latent growth curve modeling, and multilevel modeling.

A maximum of 6 credit hours of Independent Study may be used as electives with adviser's approval.

Transfer work accepted by the PAF Program must have been taken as part of an approved plan of study for a doctoral program at UCF or elsewhere. A maximum of 6 credit hours taken at the doctoral level may be considered for transfer. The acceptance of transfer credit into the elective component is dependent upon the approval of the track coordinator in consultation with the PAF Program Director.

If students receive grades of "C+" or lower in a required course, they may be dismissed from the program. Also, all students who receive a grade of "C+" or lower in a required course must repeat the course and obtain a grade of "B-" or better prior to taking the qualifying examination.

A minimum of 3.0 graduate status GPA and program of study GPA is required to maintain graduate student status and for graduation. Students with a GPA of less than 3.0 may be dismissed from the program.

Any student who receives an "F" grade in their doctoral course work will be dismissed from the program.

#### **Assignment of Faculty Advisers**

Upon acceptance of a student into the program, the program director provides students with an initial orientation and a general advising session. The track coordinator in conjunction with the PAF Program Director helps the student throughout the foundation stage of the program, assisting in the clarification of interests and goals and facilitating the introduction of students to faculty and research interests that can advance the student's program of study. Criminal Justice Track students will be advised by the Criminal Justice Track Coordinator. The track coordinator helps the student select elective courses, finalize the program of study, and facilitate the discussion and review of dissertation topics. The dissertation chair should be selected by the student prior to the completion of the dissertation prospectus.

#### **Qualifying Examination**

Following successful completion of all required courses, students are required to pass a qualifying examination. The examination is given at the end of fall or spring semesters. Students are given two opportunities to pass all sections of the exam. Students who fail any section twice are dismissed from the program. Any student who fails any section of the qualifying exam twice will not be readmitted into the PAF program. This policy includes all tracks and/or any masters to PhD program(s) with the PAF program.

#### **Candidacy Status**

Students officially enter candidacy when the following has been accomplished:

- Completion of all course work, except for dissertation hours.
- Successful completion of the qualifying examination.
- The dissertation advisory committee is formed and approved. The committee consists of approved graduate faculty and graduate faculty scholars.
- Submittal of an approved program of study.
- Submission of prospectus to turn-it-in.com. Subsequent results to be within acceptable rating.
- Successful defense of the dissertation prospectus.

#### **Equipment Fee**

Full-time students in the Public Affairs Program pay a \$40 equipment fee each semester that they are enrolled. Part-time students pay \$20 per semester.

# **Application Requirements**

For information on general UCF graduate admissions requirements that apply to all prospective students, please visit the <u>Admissions</u> section of the Graduate Catalog. Applicants must <u>apply</u> online. All requested materials must be submitted by the established deadline.

Applicants must hold a master's degree from an accredited institution, preferably in criminal justice, health, public administration or social work. Applicants who do not have a master's degree in a field directly related to public affairs may be required to take courses at the master's level in preparation for doctoral level study. This preparatory course work requirement will be communicated at the time of acceptance into the program. These courses will not substitute for the doctoral degree requirements and will generally be taken prior to beginning the doctoral level course work. Admission decisions are made for fall and spring semesters.

In addition to the <u>general UCF graduate application requirements</u>, applicants to this program must provide:

- One official transcript (in a sealed envelope) from each college/university attended for both bachelor's and master's degrees.
- Official, competitive GRE score taken within the last five years.
- A narrative statement of 1000 words or less describing the applicant's educational expectations, career aspirations, level of computer skills, and any special qualifications or experiences that may enhance the overall learning environment of the PAF program.
- Résumé.
- A writing sample, i.e., academic paper, report, etc.
- Three letters of recommendation from faculty or professionals who can assess the applicant's ability to succeed in a doctoral program.
- Applicants to this program are strongly encouraged to complete the necessary
  information requested for the ETS PPI (Personal Potential Index) report that is available
  during the GRE examination. All official PPI reports must be submitted directly to the
  UCF College of Graduate Studies (use UCF Institution Code: 5233).

Admission to the Doctoral Program in Public Affairs is granted on a competitive basis. Meeting minimum UCF admission standards does not guarantee program admissions. Final admission is based on evaluation of the applicant's abilities, past performance, recommendations, match to the program, correspondence of the applicant's career and academic interests with those of the core and affiliated faculty, and potential for completing the degree and making a significant contribution to Public Affairs.

# PROGRAM DESCRIPTION

The Master of Science in Urban and Regional Planning program is designed to produce graduates with the analytical skills and managerial knowledge to pursue successful careers in urban, metropolitan, and regional planning and closely related fields. Students will receive an interdisciplinary, holistic educational experience emphasizing sustainability and socially responsible planning.

# **CURRICULUM**

The Master of Science degree program in Urban and Regional Planning consists of 48 credit hours. Each student completes a core of nine courses (27 credit hours); a concentration in one of three areas: Environmental Planning, Health and Human Services Planning, or Transportation Planning (9 credit hours); General Electives (6 credit hours); and a Capstone Project (6 credit hours). No 4000-level courses may be used in this program. Courses and credit hours used for undergraduate degrees cannot also be counted toward the program, except for Senior Scholar students.

Students work in teams for the final product in the planning degree program under the supervision of a faculty adviser from their areas of concentration: environmental planning, transportation planning, or planning healthy communities. Students work closely with community partners and may work with the Institute for Economic Competitiveness, the Institute

for Social and Behavioral Sciences, the Institute of Government, the Center for Public and Nonprofit Management, the Center for Community Partnership, or the Metropolitan Center for Regional Studies in conducting community-based research or training projects. Part of the capstone experience is a presentation of their final project.
