Handouts: Additions of a Clinical Nurse Leader Track and a Nurse Educator Track, MSN Program. Revisions for the following programs: Nursing Post Master's Graduate Certificates, Nursing Leadership and Management track, Clinical Nurse Specialist track, I/0 Psychology Ph.D. Program, TESOL Master's Program, and the TEFL Certificate Program. Courses and special topics handout.

- Addition of a Clinical Nurse Leader Track, MSN This 36 credit hour track will be preparing students as advanced practice nurse generalists, not advanced practice specialists like the other tracks. The credits have similar general content in clinical and leadership courses plus one new course, and an internship course. This program is being offered to remain competitive with other universities within the state and the U.S., and to meet emerging needs for advanced practice nurses with clinical leadership skills. This track was approved.
- 2. Addition of a Nurse Educator Track, MSN Program This 36 credit hour track consists of a core, clinical courses, electives, specific courses in education theory, plus an internship/residency course. This track will be available entirely online. The primary difference in this track from the other MSN tracks is that it prepares for advanced practice nurse generalist/educator, not for advanced practice specialists. A question was asked if there would be enough faculty for both tracks, and Dr. Kijek indicated that they had sufficient faculty for these tracks. This track was approved.
- Revisions to the Master's Program Post Master's Graduate Certificates The advanced practice practicum was increased by 1 credit hour, thereby increasing these certificates by 1 hour each. In addition, several course changes were made to the Nurse Practitioner Graduate Certificate in this group. These changes were approved.
- Revisions to the Nursing Leadership and Management track several course changes were made to this track. These changes were approved.
- Revisions to the Clinical Nurse Specialist track several courses changes were proposed for this track. These changes were approved.
- Revisions to the I/O Psychology Ph.D. Program two changes were addressed. Psychology would like to have INP 7933 Seminar in I/O Psychology to be listed as a required course, and INP 7071 Research Methods in I/O Psychology listed as an elective course. These changes were approved.
- 7. Revisions to the TESOL Master's Program changes included adding TSL 6440 Research in Second Language as an optional required course, in addition to EDF 6481 Fundamentals of Graduate Research. They would also like to add TSL 6940 ESOL Practicum as an option for the methods courses. The committee suggested that Dr. Folse inform the Ed. Research, Tech. & Leadership Department of this change. These changes were approved.
- Revisions to the TEFL Certificate Program change consisted of changing their teaching methodology course to have 2 options instead of the current 1 course. Change was approved.
- 9. Courses and special topics see attached document for course action approvals.
- 10. A question was asked indicating that whenever an UG course is changed, can we automatically do a search of both UG and Graduate courses to make sure all changes are made that affect both UG and Graduate courses. Dr. Bishop will check with Dr. Dees regarding this.
- 11. Meeting adjourned at 11:30.
