Chair, Graduate Council Curriculum Committee,

The College of Nursing (CON) would like to continue offering the Adult-Gerontology Primary Care Nurse Practitioner Graduate Certificate for the reasons below.

- Despite the lack of enrollment within the past couple of years, the courses in the certificate program are required courses in our Doctor of Nursing Practice Program- Adult Gerontology Primary Care Nurse Practitioner Track. Therefore, we would still be offering all these courses whether we have the certificate program or not.
- 2. The CON is witnessing growth in all programs. We plan to offer new degrees and certificates in the near future. Marketing our degrees and certificate programs will be planned as part of the growth. We expect the Adult-Gerontology Primary Care Nurse Practitioner Graduate Certificate to attract students in the future.
- 3. The CON aims to build new partnership agreements with clinical partners. The certificate program may attract currently practicing nurse practitioners because of the new partnerships.
