Welcome and call to order.

Dr. Valeriya Shapoval, chair, called the meeting to order at 2:30p.m. and welcomed the committee, administrators, and guests. A quorum was established. The minutes from the March 1, 2022 meeting were reviewed and approved.

Graduate Certificate Sunsetting Report.

Emily Stettner informed the committee that the official Graduate Certificate Sunsetting process has been completed. The official memo was sent and a response was received, both are included with the agenda.

Revision of COS Integrative and Conservation Biology PhD.

Dr. Eric Hoffman and Dr. Chase Mason explained additional edits were recommended by Dr. Klonoff that are included in the proposal. These edits include removing dissertation hours from electives, increasing pre-candidacy hours from 9 to 12, and adding a list of courses in the formal coursework section. The program revision received unanimous approval.

Revision of CHPS Communication Sciences and Disorders MA; Out of Field Track; Consortium Track; Accelerated BS to MA Track.

Dr. Jacqueline Towson explained the revisions are to update the comprehensive exam language to direct students to the program handbook for the details. For the Communication Sciences and Disorders MA, Accelerated BS to MA Track, there is an additional edit to remove "BA" from the title as the Bachelor of Arts degree is no longer offered. The revisions to the program and tracks received unanimous approval.

Addition of CON Hispanic Serving Healthcare Professionals Graduate Certificate.

Dr. Desiree Diaz explained the certificate will provide allied health students and currently practicing professionals information about the unique needs in the delivery of health care to the Hispanic community. Completing students that are qualified linguistically may seek national medical translator certification in Spanish. The program addition received unanimous approval pending the Library Assessment of Resources that will be collected by the College of Graduate Studies and added to Kuali.

Revision of CBA Business Administration MBA, Evening Track.

Dr. Sevil Sonmez explained the revision includes updates to language in the curriculum to describe allowable substitutions. This will reduce eforms. The track revision received unanimous approval.

Suspension of CBA Economics MS.

Dr. Michael Caputo explained the program has not enrolled students for many years and therefore was included in the low performing report from the BOG. The proposal will officially suspend the program. The program suspension received unanimous approval.

Revision of COM Biomedical Sciences MS, Integrated Medical Sciences Track.

Dr. Steve Ebert explained the revision will create an off-ramping option for MD students who have satisfactorily completed 1.5 or more years of medical school at UCF but will not be completing the MD degree to earn an MS degree. This option is for MD students that exit the MD program for personal or other non-academic/non-disciplinary reasons. The track revision received unanimous approval.

Revision of COM Biotechnology MS.

Dr. Saleh Naser explained the revision is to core courses, resulting in an additional one credit hour to the total program hours. The courses are more current and align the MS with the PhD requirements. The revision will help students to meet program milestones as scheduled. The program revision received unanimous approval.

Revision of COS Feature Film Production MFA.

Elizabeth Kritzer explained the revision will make the curriculum clearer by revising required and elective course requirements. The program revision received unanimous approval.

Revision of CCIE Teacher Education MAT, Art Education Track.

Dr. Debra McGann explained the revision is to replace ARE 6195 with the proposed new splitlevel course ARE 5190. Offering the course as a split-level will enable the program to include undergraduate students and increase enrollment. The track revision received unanimous approval.

Revision of CCIE Public Policy Analysis Graduate Certificate; Public Policy MPP.

Edlira Dursun explained the revision is to elective courses to add course PAD 5887 Energy Policy as policy specialization content. This course is in high demand and adding it to the curriculum will reduce substitution eforms. The revisions to the programs received unanimous approval.

Revision of CCIE Public Affairs PhD.

Edlira Dursun explained the revision is to add a list of courses to the Global & Community Health Services Research specialization that is currently missing. The program revision received unanimous approval.

Revision of CCIE Public Affairs PhD, Public Administration MPA Dual Degree Track.

Edlira Dursun explained the revision is to align this track with the Public Affairs PhD curriculum. The revisions will reduce the total track hours from 84 to 81 credit hours. The track revision received unanimous approval.

Revision of CCIE World Languages Education - Languages Other Than English (LOTE) Graduate Certificate.

Dr. Sara Michael-Luna explained the revision is to add course options to increase flexibility for students. The program revision received unanimous approval.

Revision of CGS Modeling and Simulation of Behavioral Cybersecurity Graduate Certificate.

Dr. Sean Mondesire explained the revision is to add a course option to increase flexibility for students. The program revision received unanimous approval.

Revision of CECS Computer Forensics, Out of State Cohort Track Graduate Certificate.

Dr. Cliff Zou explained the revision will align the requirements of this track to the in-state version. The revision will reduce the total program hours from 12 to 9 credit hours. The program revision received unanimous approval.
