Welcome and call to order.

Dr. Daniel Paulson, chair, called the meeting to order at 2:30p.m. and welcomed the Committee and administrators. A quorum was established. The minutes from the November 5, 2025 meeting were reviewed and approved.

Revision of CCIE Dual Language Graduate Certificate.

The proposal was on the consent agenda. The proposal included revisions to required courses taught within the department. The program revision received unanimous approval.

Revision of CECS Materials Science and Engineering PhD; Materials Science and Engineering PhD, Post-Master's Track.

The proposals were on the consent agenda. The proposals included revisions to add more elective options. The track included an update to the description. The revisions to the program and track received unanimous approval.

Revision of CECS Environmental Engineering PhD; Civil Engineering PhD.

The proposals were on the consent agenda. The proposals included revisions to add GTA registration requirements in the program details. The revisions to the programs received unanimous approval.

Revision of CAH Emerging Media MFA.

The proposal was on the consent agenda. The proposal included revisions to the program description. The program revision received unanimous approval.

Revision of COS Big Data Analytics PhD.

Dr. Edgard Maboudou explained the revision is to add information about the availability of the Big Data Analytics MS, Master Along the Way Track. Some typos were pointed out in the proposal that will be fixed by the College of Graduate Studies. The program revision received unanimous approval.

Addition of COS Big Data Analytics MS, Master's Along the Way Track.

Dr. Edgard Maboudou explained the Master Along the Way Track is added to create a separate catalog entry with clear curriculum. It was determined that an Assessment of Resources from the University Library was not needed for a Master's Along the Way Track. The track addition received unanimous approval.

Addition of COS Mathematical Science MS, Master Along the Way Track; Mathematical Science MS- Financial Mathematics, Master Along the Way Track.

Dr. Carlos Borges explained the Master Along the Way Tracks are being added to create a separate catalog entry with clear curriculum. The track additions received unanimous approval.

Addition of COS Sociology, Applied MA, Master's Along the Way Track.

No representative was present. The track addition received unanimous approval.

Addition of CCIE Health Services and Informatics Research PhD.

No representative was present. The program addition received unanimous approval.

Addition of CCIE Research Methods, Measurement, and Quantitative Data Analysis. Graduate Certificate.

Dr. Debbie Hahs-Vaughn explained the curriculum includes courses that are popular and will give students an incentive to take one additional course to earn the certificate. The certificate can be taken online or mixed mode and includes nine credit hours. The program addition received unanimous approval.

Revision of CCIE Counselor Education MA, Clinical Mental Health Counseling Track.

Dr. Bryce Hagedorn explained the revision is to remove the thesis option and revise the required and clinical courses. There are no changes to the overall program hours. An entry error for MHS 6466 that should be included in Specialization courses will be fixed by the College of Graduate Studies. The program revision received unanimous approval.

Revision of CCIE Exceptional Student Education MEd, Applied Behavior Analysis Track.

Dr. Shaun Hawkins explained the revision is to reflect new course offerings. Overall program hours are reduced from 36 to 30. The changes are in alignment with national certification and accreditation standards and will enhance academic rigor and professional preparation. Six hours were specified for the capstone. The track revision received unanimous approval.

Revision of CCIE Initial Teacher Professional Preparation Graduate Certificate.

Dr. Gina Gresham explained the revision is to make the requirements clearer and remove courses no longer required by the State. The certificate transfers into the MAT. Overall program hours are reduced from 18-19 to 15 hours. The program revision received unanimous approval.

Revision of CCIE Health Administration MHA, Residential Track.

Dr. Reid Oetjen explained the revision is to change the track name from Health Services Administration to Residential track. The new language is common in the discipline. The curriculum significantly changed to meet competencies in the field. Overall program hours are increased from 51 to 57 hours. The track revision received unanimous approval.

Revision of CCIE ESOL Endorsement K-12 Graduate Certificate.

Dr. Donita Grissom explained the revision is to reduce course choices to ensure full enrollment. The revision will remove duplicate content in methods coursework. The course name change within the program will update in Kuali once the course revision proposal is fully approved. The program revision received unanimous approval.

Suspension of CCIE Crime Analysis Graduate Certificate.

Dr. William Moreto and Alexis Ritz explained the suspension is due to low enrollment and low student demand. The program suspension received unanimous approval.

Revision of CECS Quality Assurance Graduate Certificate.

Dr. Mansooreh Mollaghazemi explained the revision is to required courses to give students a choice in courses. The program revision received unanimous approval.

Addition of CECS Electrical Engineering MSEE, Electronic Parts Reliability and Qualification Track.

Dr. Enxia Zhang explained the track prepares students with advanced knowledge of semiconductor device physics, radiation effects, packaging, and reliability engineering. The track is 30 credit hours. The required research project will be clarified for the non-thesis option in the proposal. The track addition received unanimous approval.

Revision of CBA Sport Business Management MSBM.

Dr. Adrien Bouchet explained the revision is to the sport business management core in response to changes in faculty expertise and to better align the program with university and college goals. The program revision received unanimous approval.

Revision of CBA Business Analytics MS.

Dr. Harry Paarsch explained the revision is to allow for flexibility in the program to accommodate part-time students. The semester timeline format of the curriculum was removed. The program revision received unanimous approval.

Revision of CBA Accounting MSA.

Dr. EB Poziemski explained the revision includes removing specializations and revisions to required courses. The revised curriculum will provide more support for students taking the CPA exam and encourage them to complete the degree. The program revision received unanimous approval.

Addition of CBA Assurance Graduate Certificate; Taxation Graduate Certificate.

Dr. EB Poziemski explained the Assurance Graduate Certificate prepares students with auditing and assurance skills used in a financial statement, compliance, internal control, and fraud contexts. The Taxation Graduate Certificate provides knowledge in tax preparation, compliance, and research, equipping students with skills to navigate complex tax

environments. Each program is 9 credit hours. Typos in each proposal will be fixed by the College of Graduate Studies. The addition of the programs received unanimous approval.

Revision of CAH Teaching English to Speakers of Other Languages (TESOL) MA.

Dr. Gergana Vitanova explained the revision will make students more competitive in the field. An applied linguistics concentration is being added. The curriculum will complement the minor. Typos in the proposal will be fixed and UNHCR will be written out by the College of Graduate Studies. The program revision received unanimous approval.

Revision of CHPS Kinesiology MS, Human Performance Track.

Dr. Sarah Fretti explained the revision is to required courses and to the electives within the thesis/nonthesis options. The revisions will simplify the language, making the curriculum clearer for students. The track revision received unanimous approval.

Revision of CHPS Kinesiology MS, Clinical Exercise Physiology Track.

Dr. Sarah Fretti explained the revision is to required courses and internship requirements. Elective courses have been removed. The revisions will better develop clinical skills and competencies. The track revision received unanimous approval.
