Revision of CECS Electrical Engineering MSEE; Computer Engineering MSCpE.

The proposals were on the consent agenda. The proposals included revisions to the degree set up and language. There were no requirement changes. The revisions to the programs received unanimous approval.

Revision of COM Biomedical Sciences MD/PhD Track.

Dr. Saleh Naser explained the revision is to required and elective courses to align with course changes in the college. The program revision received unanimous approval.

Revision of CHPS Communication Sciences and Disorders MA; Communication Sciences and Disorders MA, Out of Field Track; Communication Sciences and Disorders MA, Accelerated BS to MA Track.

Dr. Jaclyn Lucy explained the revisions are to reduce total program hours from 72 to 67 credit hours. The reduction in credit hours will decrease student burden and costs and will create a more efficient curriculum with reduced redundancies. The program revisions received unanimous approval.

Revision of CHPS Communication Sciences and Disorders MA, Professional Track.

Dr. Jaclyn Lucy explained the revision is to reduce total program hours from 72 to 62-65 credit hours. The reduction in credit hours will decrease student burden and costs and will create a more efficient curriculum with reduced redundancies. The proposal includes a name change from Consortium Track to Professional Track. The program revision received unanimous approval.

Revision of COS Strategic Communication PhD.

Dr. Ann Miller explained the revision is to core courses, research requirements, and unrestricted electives. The revisions will modernize the curriculum and better meet the needs of incoming students. The program revisions received unanimous approval.

Revision of COS Security Studies PhD.

Dr. Jacopo Baggio explained the revision increases total program hours from 56 to 62 credit hours. The increase in credit hours is to accommodate the new Political Science MA, Security Studies Master Along the Way Track. Clarification was added to the description to explain the Master Along the Way will be a second Master's degree as the PhD program requires a Master's degree for admission. The program revision received unanimous approval.

Addition of COS Political Science MA, Security Studies Master Along the Way Track.

Dr. Jacopo Baggio explained the Master Along the Way Track is added to create a separate catalog entry with clear curriculum. The track addition received unanimous approval.

Revision of CON Nursing Practice DNP, Executive Track; Nursing Practice DNP, Advanced Practice Track; Nursing Practice DNP, Adult-Gerontology Primary Care Nurse Practitioner Track; Nursing Practice DNP, Family Nurse Practitioner Track; Nursing Practice DNP, Adult-Gerontology Acute Care Nurse Practitioner Track.

Dr. Susan Dyess explained the revisions to the curriculum will better align with competency-based education models for nurse practitioner education. The Nursing Practice DNP, Adult-Gerontology Primary Care Nurse Practitioner Track will increase from 73 to 74 hours. The program revisions received unanimous approval.

Addition of CON Artificial Intelligence (AI) in Health Graduate Certificate.

The program addition was tabled.

Revision of CECS Behavioral Cybersecurity and Privacy Graduate Certificate.

Dr. Ghaith Rabadi explained the revision is to change the name of the certificate and update the curriculum to better reflect current content and faculty strengths. The former name is Modeling and Simulation of Behavioral Cybersecurity Graduate Certificate. The program revision received unanimous approval.

Addition of CECS Electrical Engineering MSEE, Optoelectronics Track.

Dr. Mingjie Lin explained the track was designed based on student interest in the area. The track will provide knowledge and competitive skills in key areas required to excel in optics, photonics, electromagnetics, material science, and communications. The track is 30 credit hours. The track addition received unanimous approval.

Addition of CECS Mechanical Engineering MSME, Sustainable Energy Systems Track.

Dr. Jihua Gou explained the track curriculum includes courses related to sustainable energy with applications in mechanical engineering. The track will prepare students for careers as engineers in the energy industry. The track is 30 credit hours. The track addition received unanimous approval.

Revision of CCIE Elementary Education MEd.

Dr. Norine Blanch explained the revision is to required courses, updates to certificate pathways, and a revision to the thesis option course. There is no change to overall program hours. The program revision received unanimous approval.

Revision of CCIE Elementary Education MA.

Dr. Norine Blanch explained the revision is to the description, prerequisites, and to core and specialization courses. The program will decrease in total program hours from 48 to 36 hours. The reduction in credit hours will increase the appeal of the program to incoming students. The program revision received unanimous approval.

Revision of CCIE Teacher Education MAT, Art Education Track.

Dr. Debra McGann explained the revision is to the description and program details. The 3+1 BS to MAT program will be better described. These edits make the program more marketable and better suited to the teaching profession. The program revision received unanimous approval.

Revision of CCIE Public Affairs PhD.

Edlira Dursun explained the revision is to elective courses to better align the electives with the research focus curriculum. The program revision received unanimous approval.

Revision of CCIE Exceptional Student Education MEd.

Dr. Maria Busch explained the revision is to decrease the total program hours from 33 to 30 hours by removing the Thesis option and comprehensive exam. The program revision received unanimous approval.

Revision of CCIE Education PhD, Learning Sciences & Educational Research Track.

Dr. Laurie Campbell explained the revision is to combine three tracks into a renamed track. The Education PhD, Instructional Design and Technology Track has been renamed to Learning Sciences & Educational Research Track. The curriculum of two other tracks will be combined into the renamed track: Education PhD: Learning Sciences Track; Methodology, Measurement, and Analysis Track; Instructional Design and Technology Track. The revisions will streamline offerings by the department and better support students. The program revision received unanimous approval.

Suspension of CCIE Education PhD, Methodology, Measurement and Analysis Track; Education PhD, Learning Sciences Track.

Dr. Laurie Campbell explained the suspensions are to combine the curriculum from these tracks into the Education PhD, Learning Sciences & Educational Research Track. The program suspensions received unanimous approval.

Addition of CCIE Educational Leadership Modified Core Graduate Certificate.

Dr. Sheila Moore explained the certificate will formalize the curriculum, allowing for better tracking of students and an increase in recruitment efforts. The certificate will provide students with the coursework required for Florida Level I Administrative Certification. The certificate is 21 credit hours. The certificate addition received unanimous approval.

Addition of CCIE Applied AI for Innovation Graduate Certificate.

The program addition was tabled.

Suspension of CGS Interdisciplinary Studies MS, Nonthesis Track; Interdisciplinary Studies MS, Thesis Track; Interdisciplinary Studies MA, Nonthesis Track; Interdisciplinary Studies MA, Thesis Track.

Dr. Elizabeth Smock explained the suspensions are to increase flexibility for students moving between thesis and non-thesis options. The curriculum from the tracks will be moved to the main programs. The program suspensions received unanimous approval.

Revision of CGS Interdisciplinary Studies MS; Interdisciplinary Studies MA.

Dr. Elizabeth Smock explained the revision is to incorporate the curriculum from the tracks into the programs. By eliminating the tracks, the program will be more flexible for students to move from the thesis option to the non-thesis option. The program revisions received unanimous approval.
